**April 19th 2016: Sexual Violence Prevention at the State and Local Level**

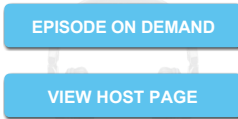

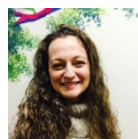

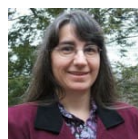
